Standard 1: Academic Model

Standard 3: Safety and Compliance

The school ensures a safe environment and maintains compliance with all applicable state and local regulations.

Required Indicators

- 3.1 Safety protocols addressing emergencies, health practices, and student well-being are documented and consistently implemented.
- 3.2 Facilities meet required safety, occupancy, and environmental standards.
- 3.3 The school engages with parents to provide proactive risk management and ongoing evaluation of safety practices.

Standard 4: Staff Qualifications and Development

The school employs qualified personnel and provides ongoing professional development that supports high-quality instruction and operations.

Required Indicators

- 4.1 Staff members meet qualifications, certifications, and background check standards.
- 4.2 The school promotes a culture of continuous learning and professional excellence.

The school demonstrates responsible financial practices that ensure long-term sustainability and stewardship of resources.

Required Indicators

- 6.1 The school prepares and monitors annual budgets that are realistic and aligned to operational needs.
- 6.2 Financial statements are accurate, documented, and regularly reviewed by leadership or governing bodies.
- 6.3 Appropriate internal controls and financial oversight measures are in place.
- 6.4 The school maintains reserves or contingency plans that support financial stability.
